Collection of your Personal Information

In order to better provide you with products and services offered, O.C.C may collect personally identifiable information, such as your:

- **First and Last Name**
- **Mailing Address**
- **E-mail Address**
- **Phone Number**

If you purchase O.C.C's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

- SSL Protocol
